This charming stone finca, completed in 1990, is a true gem in the countryside near Pollensa and offers a perfect blend of privacy, spacious interiors and exceptional outdoor living. Set on a plot of approx. 10,100sqm, the property boasts a beautifully manicured lawn with mature trees. A highlight of the outdoor area is the large swimming pool next to a spacious terrace with barbecue area, from where you can enjoy the breathtaking views of the Puig de Son Sant Martí and Alcudia. For quieter moments, there is also a cozy, covered terrace from which you can enjoy the same breathtaking views in peace and quiet. Not far from the house is a carport as well as the laundry room and utility room.

The property exudes the charm of idyllic country living and is located in a quiet area just a short drive from Pollensa's historic old town. The beaches of Puerto Pollensa can be reached in 8 minutes, while Playa de Muro is only 15 minutes away.

The main house has 2 double bedrooms and a shared bathroom. The heart of the house is the spacious living room with its high ceilings and rustic wooden beams, which is connected to the kitchen and dining area. From here you have direct access to the pool terrace, which is perfect for entertaining or simply enjoying the Mediterranean lifestyle. The property also has 2 separate guest studios, each with a bedroom and bathroom. Together, the accommodations comfortably sleep up to eight guests as stated in the valid vacation rental license.

A well and a water deposit, which is replenished by deliveries, cover the property's water needs and the finca is connected to mains electricity. It should be noted that the finca is currently being legalized, with the associated costs to be borne by the future owner.
