Objektbeschrijving:

This lovely finca was built in 2005 and is situated on a sloping, north-east facing plot of 15,700 sqm providing great privacy and tranquillity. It is only 10 min from the sandy beach of Playa de Muro and the old town districts of Alcudia and Pollensa.

A paved driveway leads to the main house with a living area of an incredible 450 sqm spread over 2 levels. Distributed over the ground floor there is a spacious fitted kitchen with dining area and access to the south-facing terrace, a guest WC, a large living room with fireplace and floor-to-ceiling windows providing breathtaking views over the Alcudia valley as far as the bay of Pollensa, and a separate guest apartment with 2 double bedrooms, a bathroom, a kitchenette and a living area. This living area surrounds a charming inner patio with a mature wild-olive tree.

In the exterior area there is a covered terrace with dining area and outdoor kitchen, next to the 56 sqm pool, the beautifully landscaped garden and a private tennis court. A photovoltaic system is installed on a casita next to the pool, and there is also a well so that the finca is self-sufficient regarding energy and water supply.

On the upper level there are 2 double bedrooms, a bathroom, and the master suite with a walk-in wardrobe and a private bathroom. A covered terrace on this level provides sensational views of the surrounding landscape

The cellar area of the finca houses a large storage room, the house-technology room, and ample parking space for diverse vehicles. Further features include double glazed windows throughout and air conditioning in all the rooms.

This exceptional property is perfectly maintained and offers a very high level of living comfort. It has a valid touristic rental license, and its certificate of habitability was recently renewed.
